# Introduction of Investor Risk Reduction Access (IRRA) platform in case of disruption of trading services provided by the Trading Member (TM)

Reserve Bank of India in exercise of powers conferred under Section 11(1) of the Securities and Exchange Board of India Act, 1992 vide notification dated 30.12.2022, introduced Investor Risk Reduction Access for investors with open positions are at risk of non - availability of avenues to close their positions, particularly if markets are volatile.

They shall come into force with effect from the 1<sup>st</sup> day of April, 2023.
