# 1. The Securities Transaction Tax (1st Amendment), Rules, 2022

The Central Government, in exercise of the powers conferred section 114 of the Finance (No. 2) Act, 2004, (23 of 2004), vide notification dated 18.01.2022 made the Securities Transaction Tax (1st Amendment), Rules, 2022 to amend the Securities Transaction Tax Rules, 2004.

# 1. Registration of Assignment of Receivables (Reserve Bank) Regulations (14.01.2022)

Reserve Bank of India, in exercise of the powers conferred by section 19 (1A) read with Section 31A of the Factoring Regulation Act, 2011 (12 of 2012), vide circular dated 14.01.2022, released regulations pertaining to the manner of filing of particulars of transactions with the Central Registry by a Trade Receivable Discounting System (TReDS) on behalf of Factors.

The regulations shall come into force on the date of their publication in the Official Gazette.

# 2. Registration of Factors (Reserve Bank) Regulations (14.01.2022)

Reserve Bank of India, in exercise of the powers conferred by section 3 read with Section 31A of the Factoring Regulation Act, 2011 (12 of 2012), vide circular dated 14.01.2022, made regulations pertaining to the manner of granting Certificate of Registration to companies that propose to do factoring business.
