MINISTRY OF CORPORATE AFFAIRS

The Central Government, in exercise of the powers conferred by sub-section (1) of section 67 of the Limited Liability Partnership Act, 2008 (6 of 2009), vide notification dated 11.02.2022 directed that the provisions of sections 90, 164, 165, 167, sub-section (5) of section 206, sub-section (3) of section 207, 252 and section 439 of the Companies Act, 2013 (18 of 2013), shall apply to limited liability partnership, except where the context otherwise requires, with the modifications specified in the table given in the notification.

The Central Government, in exercise of the powers conferred by sub-sections (1) and (3) of section 128, sub section (3) of section 129, section 133, section 134, sub-section (4) of section 135, sub-section (1) of section 136, section 137 and section 138 read with section 469 of the Companies Act, 2013 (18 of 2013), vide notification dated 11.02.2022 made the Companies (Accounts) Amendment Rules, 2022, further to amend the Companies (Accounts) Rules, 2014.

The Central Government, in exercise of the powers conferred by sections 17, 69, 72, 76A and 79 of the Limited Liability Partnership Act, 2008 (6 of 2009), vide notification dated 11.02.2022 made the Limited Liability Partnership (Amendment) Rules, 2022 further to amend the Limited Liability Partnership Rules, 2009, and these shall come into force with effect from the 01.04.2022.
