1. The Income-tax (Thirty Third Amendment) Rules, 2022.

The Central Board of Direct Taxes, in exercise of the powers conferred by section 285BA read with section 295 of the Income-tax Act, 1961 (43 of 1961), vide notification dated 07.10.2022 made the Income-tax (Thirty Third Amendment) Rules, 2022, further to amend the Income-tax Rules, 1962.

1. Appointment of Internal Ombudsman by the Credit Information Companies

Reserve Bank of India in exercise of powers conferred under sub section (1) of Section 11 of the Credit Information Companies (Regulation) Act, 2005 (the Act) vide notification dated 06.10.2022 under which the Reserve Bank of India, being satisfied that it is in public interest to do so, directs all Credit Information Companies holding a Certificate of Registration under sub-section (2) of Section 5 of the Act, to comply with the Reserve Bank of India (Credit Information Companies- Internal Ombudsman) Directions, 2022

1. Extension of timeline for entering the details of the existing outstanding nonconvertible securities in the 'Security and Covenant Monitoring' system hosted by Depositories.

SEBI in exercise of powers conferred under Section 11 (1) of the Securities and Exchange Board of India Act, 1992 read with the provisions of Regulation 2A of the Securities and Exchange Board of India (Debenture Trustees) Regulations, 1993, Regulation 55of the Securities and Exchange Board of India (Issue And Listing Of Non-Convertible Securities) Regulations, 2021, Regulation 29 of the Securities and Exchange Board of India (Issue and Listing of Municipal Debt Securities) Regulations, 2015, Regulation 48 of SDI Regulations, 2008and Regulation 20 of SEBI (Credit Rating Agencies) Regulations, 1999, vide circular dated 03.10.2022, provided for extension of timeline for entering the details of the existing outstanding non-convertible securities in the 'Security and Covenant Monitoring' system hosted by Depositories to protect the interest of investors in securities and to promote the development of, and to regulate, the securities market.
