Ashram Marg, metro line 7 extension from Mukundpur (Majlis Park) to Maujpur in respect of the National Capital Region in National Capital Territory-Delhi.

## **SECURITIES AND EXCHANGE BOARD OF INDIA**

Revision in Orders per Second limit for algorithmic trading in Commodity Derivatives Segment of the Stock Exchange.

Securities and Exchange Board of India, in exercise of powers conferred under Section 11(1) of the Securities and Exchange Board of India Act, 1992, vide circular dated 17.03.2022, has been decided to permit Stock Exchanges to further relax the aforesaid limit upto one hundred and twenty (120) OPS, as against the present hundred (100). The provisions of this circular shall come into effect from April 01, 2022.
